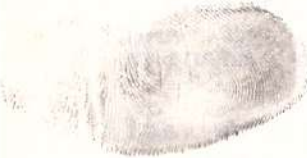

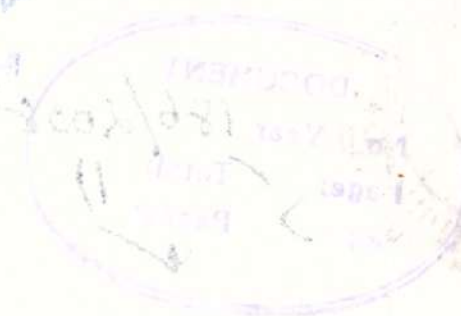

#### BOARD OF TRUSTEE :

1. The number of Trustees of the trust including the Managing Trustee shall be at all time be not more than five.
2. The trustee shall hold such office as trustees until their lifetime unless they should vacate the office earlier for any reason whatsoever. In the event of there being a vacancy in the office of such Trustees, the other Trustee shall have powers in consultation with other Trustees, to nominate a person in such a vacancy, who shall, in turn, hold office till lifetime unless he voluntarily vacate his office or dies while in office.
3. The Trustees shall be at liberty to donate to any other Trust at Trusts having objects similar to those of these presents.
4. The Trustees shall have powers to frame rules for the efficient functioning of the Trust which shall not be repugnant to any of the objects or any other clauses of these presents.

5. The Trustees shall be entitled to and be at liberty to accept gifts or any voluntary contributions, either in cash or in kind from any person.
6. The Trustees shall meet then and there, either at the office of the Trust or at such other place or places as may be convenient to them, for the purpose of implementing the objects of the Trust and for finalising the ways and means by which such objects shall be implemented. The Trustees shall also maintain a minute book for the purpose of recording the discussions carried out and the resolutions passed at such meetings. In the event of there being any difference amongst the Trustees, Chairman of Trust shall have the casting vote.
7. The Trustees shall cause maintenance of regular accounts of its receipts and expenditure of the Trust on their own responsibilities and such books of accounts shall be closed every year on the 31st March of each year, which shall be audited by a duly qualified Chartered Accountants.
8. If at any time, the Trustees, then holding such office, should find in difficult or impossible to run the Trust and pursue the objects for which the Trust has been created, the assets and liabilities of the Trust shall be handed over to any other Trust having similar objects, registered under the provision of Income tax Act, as may be chosen by the Trustees then holding such office, and it is hereby clarified that under such circumstances no asset of the Trust shall devolve or any other Trustees or their successors or their assigns on their relatives.
9. The Trustee shall be on all time, indemnified in respect of any act that may be performed bonafiedly by them in respect of matters relating to the Trust.

#### POWERS OF THE BOARD OF TRUST

The Trust Board shall have the following power.

- i (a) To receive gifts, donations, voluntary contributions, either for corpus or revenue either in cash or in kind from any source and receive assets by ways of settlement of movable and immovable property with or without any constitutions.
- (b) To give donations or made contributions in cash of kind to other public charitable Trusts or organisations having similar objects.
- ii To invest the funds of the Trust to such manner as is prescribed under the provisions of the Income tax Act from time to time. No investment would be made which would violate the provisions of section 11 (5) of Income Tax Act, 1961.
- iii To manage the Trust Fund and collect the income thereof.

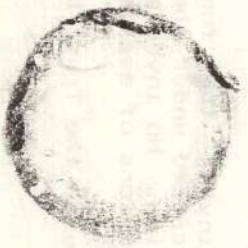

- iv To pay and discharge out of the income of the Trust fund all expenses and charges for collecting and recovering the income of the Trust and all other costs, charges, expenses and outgoings incidental to the administration of the Trust.
- v To apply the net income of the fund for all or any more of the objects of the Trust as contained herein and for accumulating the investment of surplus funds either for specific purpose or object or as investment.
- vi To acquire, own and possess build, alter, repair, improve, sell, rent or dispose off any land and building or premises acquire for the use of the Trust and to acquire other movable and immovable properties for the objects set out above.
- vii  To take on lease, or licence on hire any movable or immovable property.
- viii To enter into contract on behalf of the trust.
- ix To borrow any money with or without security on any of the properties of the trust and to issue receipt thereof.
- x To create endowments and charities to accomplish the objects of the trust.
- xi (a) To open and close accounts with banks and to operate such accounts and pay or withdraw money from such accounts.  
(b) To draw, make, accept, endorse, discount, negotiate, execute and issue cheques, bills of exchange, and other negotiable instruments.
- xii To institute and conduct any legal proceedings, claims or disputes by and against the Trust or Trustees.
- xiii To carry out all transactions as are necessary and considered expedient in the interests of the trust.
- xiv The Trust Board may frame bye laws, rules for proper and effective administration of the Trust. The Powers to effect amendment to the Trust Deed Bye laws given to the Trustee would not extend to altering the basic character/objects of the Trust and further no such amendments which may prove to the repugnant to the provisions of section 2(15), 11, 12 & 13 and 80G of the Income Tax Act.
- xv Any amendment to the Trust Deed/Bye law will be carried out only with the prior approval of the Commissioner of income tax under jurisdiction.
- xvi The activities of the Trust shall be restricted to and within India.
- xvii Any income or property or part thereof shall not apply for the benefit of any person referred to subsection 3 of section 13, either directly or indirectly.
